The impact of the current crisis on a long-term deficit is also considered. The municipal trajectory is analyzed within the regional and national programming contexts. Special attention is devoted to third sector and voluntary organizations in providing services not delivered by the state.

In Reggio Calabria cuts in the public support of care services have escalated. The municipality is on the verge of bankrupcy and under compulsory administration. The impact of the recent crisis has worsened a long-standing deficit, essentially due to the lack of programming capabilities of both the regional and the local governments and has increased their abdication to the private sector, voluntary organizations and families. Also important in the case of care for older people is the lack of coordination between the social and health component of services.
