Title of case study	"Aiming to live at home for as long as possible". Comparing familiarisation of care services for older people in the Scandinavian countries
Country/region/place investigated	Norway, Sweden and Denmark
Social service sector(s) investigated (Erase non relevant ones) • Care for older poeple	In Scandinavia, as in many other countries, it has for long been an explicit goal to make the elderly able to live at home for as long as possible. In recent years, and encouraged by national state legislation and financial incentives in Norway, there has been a dramatic change - away from offering places in nursing homes for care needing older people, towards offering equivalent services in assisted housing. In Norway assisted housing is not an "all inclusive" concept, but considered as living in private dwellings. This leaves significant reponsibility to the recident and their relatives to organise care services, medical attention etc. We hereby witness a "creeping" familiarisation of care services for older people in Norway, where a side-effect of a policy reform is offloading of public sector responsibility. Sweden and Denmark have followed somewhat different paths in their development of home-based services for older people. The question posed in this project is to what extent the developments found in the other Scandinavian countries reassemble the Norwegian development in direction of increased familiarisation of care services for older people.
